
**ADMINISTRATIVE ORDER OF THE

Unless otherwise specified, all assignments are made to Individual Assignment Parts for the 13 terms set forth above, and such parts are established for the determination of all actions as may come before the courts, including motions, trials and other proceedings in connection therewith. All inter-district assignments of Supreme Court Justices are to Supreme Court in the designated county. All courts shall be open for business Monday through Friday each week of the year, except for legal holidays. The legal holidays for 2021 are as follows:

\*Columbus Day holiday. Accordingly, Term 10 will be extended through Monday, October 11, 2021 and Term 11 will commence on Tuesday, October 12 2021.

\*\*The holiday recess will commence on Monday, December 27, 2021 and will continue through Thursday, December 30, 2021.

Jurors shall be summoned to appear as directed by the Judge scheduled to preside.

Grand jurors shall be summoned to appear on the opening day of the terms so designated and shall continue until the day preceding the commencement of the next succeeding grand jury term, unless otherwise specified herein or directed by the Justice or Judge presiding at such term.

The District Administrative Judge shall have the authority to adjust modify, and/or cancel, in consultation with the appropriate Deputy Chief Administrative Judge, the terms of court for the impaneling of grand jurors and the number of panels designated for such terms as set forth in the annual orders for Terms 1 through 6 (subject to further order).

The District Administrative Judge may establish local calendar rules consistent with the Rules of the Chief Administrator for the timely administration of justice.
